Nay(s): None


Absent: Alderman Brian Ramsey

The Mayor reopened the meeting and announced that there was no action taken by the Board of Aldermen during the Executive Session.


There being no further business before the Board of Aldermen, the Mayor adjourned the meeting at 6:23 p.m.
